## REQUIREMENTS

Book must

- be professionally bound
- display the title on the spine
- have an attractive cover
- have an ISBN
- be free of typos and errors

Author must

- read *Submission Guidelines For Authors*, available on [www.SandmanBooks.com](http://www.SandmanBooks.com)
- have and implement a marketing strategy for the book
- publicize availability of the book at Sandman during interviews, on the Author's website, in social media, etc.

## TERMS

- 1) **APPLICATION FEE.** Author must pay a non-refundable application fee of **\$8.00** per title.
- 2) **PAYMENTS.** After each sale, Author retains proceeds in the amount of **60%** of Price; Sandman will remit payments **QUARTERLY** (or earlier at Sandman's discretion).
- 3) **STOCK.** Sandman will stock the book for a term of six months. At the end of that period, the consignment agreement may be extended or terminated.
- 4) **TERMINATION.** If the agreement is terminated, Author may take possession of unsold Books during business hours at 16480 Burnt Store Road, Punta Gorda, FL. Author must notify Sandman at least one business day prior to pickup. Author may choose to have books shipped, with the cost of shipping paid by Author. If Author does not take possession of unsold Books within two weeks of notification, disposition of Books is up to Sandman.
- 5) **LIABILITY.** Liability of loss remains with Author. Sandman is not liable for damage, theft or any other loss.
- 6) **CONFIDENTIALITY.** The terms of this agreement shall remain confidential.
- 7) **GOVERNING LAW.** This agreement will be governed by the law of the state of Florida.
- 8) **MODIFICATION.** This agreement may be modified only by a written agreement signed by all the parties.
